# Title I Parental Engagement Policy 2023-2024

WHEREAS, Franklin Towne Charter High School (FTCHS) is responsible to adhere to all guidelines put forth regarding the receipt and usage of all Title I funds, we have outlined all the required components below:

#### **PART I: General Expectations**

The School agrees to implement the following statutory requirements:

- The school will put into operation programs, activities, and procedures for the engagement of parents

  Those programs, activities and procedures will be planned and operated with meaningful consultation
  from parents of participating children in order to improve student academic achievement and school
  performance.
- The school will engage parents and family members in the joint development of the Title I Plan (ESSA, Section 1116(a)(2)(A)).
- Consistent with section 1116, the school will ensure that these parental engagement policies
  meet the requirements of section 1116(A) of the ESSA, and include, as a component, a schoolparent compact.

## PART II: DESCRIPTION OF HOW SCHOOL WILL IMPLEMENT REQUIRED PARENTAL ENGAGEMENT POLICY COMPONENTS

- I. The School will take the following actions to engage parents in the joint development of the Title I plan under
  - a. Solicit feedback from parents during meetings of FTCHS.
  - b. Share draft plan with parents via a focus group and solicit feedback from participants.
  - c. Incorporate parent feedback into plan before it is brought in front of the Board of Trustees for approval.
- 2. The School will take the following actions to engage parents in the process of school review and improvement under (ESSA, Section l 116(a)(2)(.4)):
  - a. Solicit feedback from parents during regular meetings of FTCHS.
  - b. Provide ongoing parent training on topics related to school improvement.
  - c. Inform parents of their right to be engaged in our Title I, Part A programs and request regular meetings via a posting in the Student-Parent Handbook.
  - d. Provide parents with the contact number for the school's Federal Programs Coordinator via a posting in the Student-Parent Handbook and/or website.
- 3. The School will coordinate and integrate parental engagement strategies in Part A with parental engagement strategies under the following other Federal, State, and local programs: [School Improvement Grant, IDEA, Farm to School, NSLP, etc. (as applicable)], by:
  - a. Including the Federal Programs Coordinator on the advisory boards of the programs above.

The School will conduct, with the meaningful engagement of parents and family members, an annual evaluation of the content and effectiveness of this parental engagement policy in improving the academic quality of the school. The evaluation will include identifying barriers to greater participation by parents and family members, with particular attention with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background; identifying the needs of parents and family members to assist with the learning of their children, including engaging with school personnel and teachers; and identifying strategies to support successful school and family interactions. The school will use the findings of the annual evaluation to design evidence based strategies for more effective parent and family engagement, and to revise, if necessary (and with the engagement of parents) its parental engagement policies.
- 5. The School will build the school and parent's capacity for strong parental engagement, in order to ensure effective engagement of parents and to support a partnership among the school, parents, and the community to improve student academic achievement and school performance, through the following activities specifically described below:

    - v. how to monitor their child's progress
    - vi. how to work with educators.
  - Activities will include training provided at parent engagement activities, workshops, communication with home, etc.

- c. The school will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental engagement.
- d. The school, with the assistance of its parents, will educate its teachers, specialized instructional suppoli personnel, and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents and family members, and in how to implement and coordinate parent programs and build ties between parents and family members and schools, by providing ongoing professional development.
- e. The School will ensure that information related to school and parent programs, meetings, and other activities is sent to the parents and family members of participating children in a format and to the extent practicable, in a language the parents and family members can understand.

### PART III: USE OF FUNDS

  - d. Collaborating, or providing subgrants to schools to enable such schools to collaborate with, community-based or other organizations or employers with a record of success in improving and increasing parent and family engagement (ESSA, Section 1116(3)(D)(iv)).
  - e. Engaging in any other activities and strategies that the LEA determines are appropriate and consistent with the School's parental engagement policies (ESSA, Section 1116(3)(D)(v)).

- Use the parent representatives on the Board of Trustees to provide advice on matters related to parental engagement in Title I, Part A program

- Developing appropriate roles for community-based organizations and businesses, including faith-based organizations, etc., in parental engagement activities
- Providing other reasonable support for parental engagement activities under Section 1116 as parents may request.

NOW, THEREFORE, BE IT HEREBY RESOLVED, that the Franklin Towne Board of Directors adopts the Title I Parent Engagement Policy for the year 2023-2024 as outlined above and hereby directs the school administration to implement this plan with fidelity.
